

**TO THE HONORABLE BOARD OF COMMISSIONERS OF BERRIEN COUNTY:** Your County Personnel and Human Services Committee respectfully recommends the adoption of the following:

**RESOLUTION**

**WHEREAS**, the Michigan Department of Health and Human Services (MDHHS) desires to update the contract titled the Comprehensive Agreement for the fiscal year 2020-2021 (October 1, 2020 to September 30, 2021) previously approved under Resolution P2007303, updated under resolutions P2008313, P2010347, P2011374, P2011382; and

**WHEREAS**, this agreement ensures the provision of public health services in accordance with the Michigan Public Health Code (1978 PA 368) and MDHHS policies and protocols; and

**WHEREAS**, this update reflects new funding from the State of Michigan to cover expenditures related to COVID-19 vaccination activities including staffing, communications and supplies totaling \$133,544; for Benton Harbor Water Filter Lead Response expenses totaling \$65,000; for 189,414 of carry forward funding from FY20 under the PHEP COVID-19 response award; for \$10,000 additional funds under the Taking Pride in Prevention program; for \$36,494 under a new award for the Maternal Infant Home Visiting Initiative; added funding in the amount of \$8,975 for the WIC Breastfeeding program; a reduction in funding of \$155,000 under the Michigan Adolescent Parenting program; a reduction in funding for of \$29,061 under the Michigan Health & Wellness 4x4 Grant; and \$1,577 in reductions over several smaller programs; and


**WHEREAS**, MDHHS requires the Agreement, if accepted, be executed through the authorized electronic signature of BCHD; and

**WHEREAS**, the Board of Health endorses the acceptance of this Agreement, subject to approval by Corporate Counsel.

**NOW, THEREFORE BE IT HEREBY RESOLVED**, that the Berrien County Board of Commissioners accepts this update to the Comprehensive Agreement FY2020-21 for a revised contract total of \$5,035,001.

**IT IS FURTHER RESOLVED** that the Berrien County Board of Commissioners authorizes and directs BCHD's Health Officer/Director to electronically sign or execute, as prescribed by MDHHS.


